## 1. Aims

Schools are required under the Equality Act 2010 to have an accessibility plan. The purpose of the plan is to:

- Increase the extent to which disabled pupils can participate in the curriculum
- Improve the physical environment of the school to enable disabled pupils to take better advantage of education, benefits, facilities and services provided
- Improve the availability of accessible information to disabled pupils

Our school aims to treat all its pupils fairly and with respect. This involves providing access and opportunities for all pupils without discrimination of any kind.

The plan has been produced in consultation with the management of the school and staff and will be a working document that is constantly under review. We are committed to ensuring that we provide an inclusive environment for all that use the site regardless of their educational, physical, sensory, social, spiritual, emotional and cultural needs. We are also committed to challenge attitudes about disability and accessibility to raise awareness

The school has approximately 1200 students and up to 100 staff that use the site on a daily basis. The school has a lot of older buildings which have been built onto over different periods of time. These all comply with relevant legislation for access. The school is used for many extracurricular events that run outside the hours of the normal school day. Examples of which are concerts, award ceremonies, hire of main hall and sports clubs using the sportshall. These involve members of the public and parents accessing the school at these times. The site does run a Personal Emergency Evacuation Plan (PEEP) for every student and staff member that potentially has a difficulty in evacuating buildings in an emergency.

The plan will be made available online on the school website, and paper copies are available upon request.

Our school is also committed to ensuring staff are trained in equality issues with reference to the Equality Act 2010, including understanding disability issues.

The school supports any available partnerships to develop and implement the plan.

Our school's complaints procedure covers the accessibility plan. If you have any concerns relating to accessibility in school, this procedure sets out the process for raising these concerns.

We have included a range of stakeholders in the development of this accessibility plan, including appropriate pupil, parents, staff and governors of the school.

#### 2. Legislation and guidance

This document meets the requirements of <u>schedule 10 of the Equality Act 2010</u> and the Department for Education (DfE) <u>guidance for schools on the Equality Act 2010</u>.

The Equality Act 2010 defines an individual as disabled if he or she has a physical or mental impairment that has a 'substantial' and 'long-term' adverse effect on their ability to undertake normal day to day activities.

Under the <u>Special Educational Needs and Disability (SEND) Code of Practice</u>, 'long-term' is defined as 'a year or more' and 'substantial' is defined as 'more than minor or trivial'. The definition includes sensory impairments such as those affecting sight or hearing, and long-term health conditions such as asthma, diabetes, epilepsy and cancer.

Schools are required to make 'reasonable adjustments' for pupils with disabilities under the Equality Act 2010, to alleviate any substantial disadvantage that a disabled pupil faces in comparison with non-disabled pupils. This can include, for example, the provision of an auxiliary aid or adjustments to premises.

Funds will be made available to make reasonable adjustments where appropriate.

#### 3. Monitoring arrangements

This document will be reviewed every 3 years, but may be reviewed and updated more frequently if necessary.
